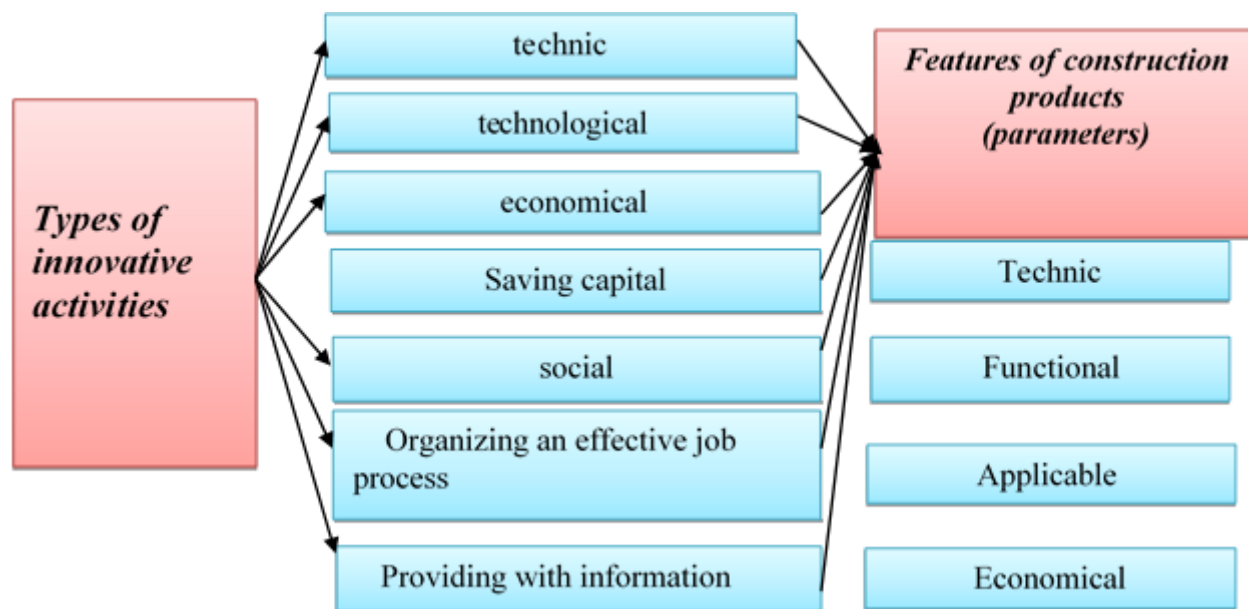


Figure 1. Types of innovative activities and construction products effect on properties²
