

About the Defoliant Ento Defol and its Effects on Plants and Living Organisms

Abstract: Avguron Extra penetrates the leaves of the plant within 12 hours. The first signs of effect (decrease in the intensity of leaf color and falling of individual leaves) appear on the 2-4th day after treatment. The drug stimulates the formation of a separating layer of cells. As a result, the leaves turn green and do not dry out. It eliminates the contamination of cotton raw materials during harvesting, as there are no dried leaves left on the bushes. Avguron Extra also prevents the regrowth of leaves. The drug accelerates the natural ripening of unopened bolls, so the quality of the fiber does not deteriorate.

When treating cotton, do not spray the product on other crops or trees, as this may damage them or cause unwanted leaf drop.

It is recommended to carry out defoliation in the morning or evening hours, when the wind speed does not exceed 3 m/s. If the temperature is expected to drop below 12 ° C within 2-3 weeks after spraying, the treatment should not be carried out.

The highest effectiveness of the drug is achieved in the temperature range from 17 to 33 ° C. At temperatures below 17 ° C, the penetration of the drug into plants worsens, which is associated with a slowdown in physiological processes.

The preparations should be mixed with water in the spray tank in the following order: SP (in water-soluble packets) → SP → VDG (STS) → Avguron Extra, SK → SK (VSK) → SE → KNE (KME, ME, KE, EMV) → VRG → VRK (VR) → VRK (VR) → VRK. Each subsequent component is added after the previous one is completely dissolved (dispersed).

The highest efficiency of using Avguron Extra is achieved with optimal soil moisture during the defoliation period (65% to 70% of the total field moisture). In case of drying, light irrigation should be carried out approximately 2 weeks before defoliation. It is not recommended to sow lettuce and carrots earlier than 9 months after applying the drug; legumes, alfalfa, other root vegetables and leafy vegetables earlier than 2 months.

Before opening the canister with the drug, shake it well. It is recommended to first prepare a stock solution of the drug. To do this, fill a small container (bucket) with ¼ of water, then add the measured amount of the drug to fill one sprayer and, stirring well, add water to ¾ of the volume. After that, the sprayer container is filled with water to ½ of the volume, the mixer is turned on and the mother solution of the drug is poured into it. After obtaining a homogeneous solution, water is added to the container until the volume is full, stirring constantly. To ensure the homogeneity of the working fluid, stirring continues during the processing. The prepared working fluid should be used on the same day. Among them, thidiazuron does not directly damage cotton leaves, can stimulate ethylene production and inhibit auxin transport. 24 hours after application, the ethylene released from the leaves peaked, and then remained at a certain level until the leaves were defoliated. It can remove mature leaves and effectively remove young leaves. Diuron is a sulfonylurea herbicide and a photosynthesis inhibitor. After mixing, the two drugs not only have complementary and synergistic effects, but also have good low temperature stability, and can effectively reduce dosage and reduce costs.

Unbroken, dry, broken leaves easily stick to the cotton wool and contaminate the cotton wool, which reduces the quality of the cotton and also causes a lot of inconvenience when picking cotton by hand, especially when picking by machine.

Thidiazuron-Diuron mixture is imported with high-performance adjuvants. After application, cotton plants themselves can produce abscisic acid and ethylene, which causes the formation of a separating layer between the petiole and the cotton plant, which allows the cotton leaves to be self-seeded; The leaves can quickly transfer nutrients to the young cotton on the upper part of the plant, achieving the effect of maturation, defoliation and increasing yield; Cotton can be early, the cotton and bolls are relatively developed, and the proportion of pre-frost cotton is increased. It does not contain cotton husk, does not fold, does not fall off, increases the length of the fiber, increases the wear, and facilitates mechanical and manual harvesting; The long-term effect of the medicinal effect basically solves the problem of "drying without falling off", reduces the number

of pairs of blades. The pollution of cotton picking by machine improves the quality and efficiency of mechanized cotton picking. Cotton is very sensitive to thidiazuron. Usually, 4-12 hours after use, the amount of ethylene produced by cotton increases significantly. At the same time, thidiazepine inhibits the growth of auxin in plants and acts on plants to promote the growth of plants. Cytokinin. This special mechanism of action does not stop the metabolism of the plant, ensuring the normal process of capsule ripening. Thidiazuron can cause rotting of cotton leaves without destroying chlorophyll and does not change the water potential of the leaf.

Diuron is a sulfonylurea herbicide with systemic and pronounced contact activity. When the agent is taken up by the roots and leaves of the plant, photosynthesis can be inhibited, resulting in chlorosis, leaf tips and leaf margins discolouration, which leads to plant death due to lack of nutrition.

After treatment with thidiazuron and diuron, cotton leaves can be torn off in advance, the leaves will be quickly regrown, and the leaves will be effective early and quickly, within 7-10 days. The effect of defoliation and ripening will be obvious 30 days after the drug is applied. Up to 88.65% -93.75%.
