"It's been 3000 thousand years since the creation of our venerable, ancient manuscript "Avesta".

#### The main part.

This rare book is the spiritual and historical legacy of our ancestors who lived on this land between two rivers 30 centuries ago. "Avesta" is a historical document that testifies to the existence of a great state, great spirituality, and great culture in this ancient country, and no one can deny it",[1] it is not for nothing. In this religion, a lot of attention is paid to issues of social support of the family. Here comes the question of what is social protection. Social protection is a set of legal, economic and social measures that ensure social and material protection of the country's population and are established in society. Social protection is not only the use of people materially, but the ideas of humanity and justice are at its core. In order to protect against the influence of various information flows into our society today, it remains urgent to mediate and publicize the issue of the thousand-year-old family and its protection in our society.

Zoroastrian asked Ahura Mazda, "What will you give to the household of Serfarzand?" When asked, he answers: "I will take such people under my protection." That is why wealthy families and pregnant women are socially protected by the community. Families with many children were given allowances from the state treasury, and women who gave birth to 2-3 children at once were given benefits and rewarded with a cow or a yellow camel.[3]

In the Zoroastrian religion, faith is based on the following three foundations: 1) purity of thought; 2) stability of the word; 3) humanity of actions. In Zoroastrian religion, there are issues of being kind to orphans and widows, being hospitable, being tolerant of people of other religions, envying one's good deeds, and abstaining from hard-earned income. Also, in the "Yasht" section of the "Avesta" book..."I will remove hunger and thirst from the creatures created by Mazda; turn the infirmity of old age and death away from the form of Mazda; "The warm wind and the cold body will fly away from Mazda's world for a thousand years" as living values of humanity and family play an important role in the history of society.

#### Result and discussion

Zoroastrian religion issues of family and marriage and child rearing In Zoroastrianism special care for pregnant women was introduced. Men were required to take special care of women, to take care of the fetus before birth and after birth. This requirement was applied even to domestic dogs. In it, the ideas of love, family, marriage, and having many children help to solve the current demographic problems. In the Zoroastrian religion, killing a fetus out of wedlock (abortion) is punishable by death. Especially today, we can see that the death of a child or not giving birth is one of the problems in some countries. However, in this religion, a man who is married and lives with his wife is valued. Young men and women who refused to marry were severely punished. "In Avesta philosophy, man is described as the most honorable creature created by God. Friendship, goodness, mutual respect should be the law of people's life" [4], it is said.

The speed of development depends in many ways on the strength of the family. The level of development of the society is clearly reflected in the family. That is why the issues of man, family and marriage have always been one of the main problems of science and education and state policy. Zarathustra, a great sage and religious reformer of his time, humanized the attitude towards family life. "Love is a torch that lights your way," says Zarathustra. These thoughts allow people to distinguish good from evil. Faithful people are certainly on the side of goodness.

In addition, thoughts aimed at improving the social condition of the people are also stated. In this teaching, the basis of Zoroastrian ethics is good thoughts, good words and good deeds. It is necessary to follow these three beliefs together. We can see that these noble ideas of Zoroastrianism are in harmony with the principles of "Human rights and freedoms are above all else", that is, "The state is for the human being", which is being established in modern Uzbekistan.

#### **Summary**

Today, women, who make up more than 17 million members of our society, have always worked together with men to create material and spiritual blessings. The Vendidot part of "Avesta", which consists mainly of prose narratives, describes in detail the preservation of family integrity, marriage procedures, the obligation of the spouses, the reason and conditions for annulment of marriage. Ahuramazda says: "O Spitamon Zarathustra! I respect men with families more than brave men without families. Whoever financially helps a young man who has reached the age of majority to get married, I will reward him in this world and in the next."
