

## COOPERATION OF THE PREVENTION INSPECTOR OF THE PLACE OF LAW AND ORDER WITH CITIZENS IN THE IMPLEMENTATION OF CRIME PREVENTION

**Annotation:** The article describes the essence and specific features of the prevention inspector's cooperation with citizens in the implementation of crime prevention, the main directions, methods and forms, problems and shortcomings in the organization of cooperation and their solutions.

**Key words:** prevention inspector, citizens, neighborhood, crime, crime prevention, crime prevention measures.

Patriotism, patriotism, justice, truth, humanity, forgiveness, mercy, compassion, tolerance, honesty, which is a sacred and ancient, passed down from generation to generation, the main criterion of the life and activities of our great ancestors, and an integral part of the spirituality of the Uzbek people, which is mixed with humanity. characteristics such as religion are embedded in our national traditions. It is based on such values as glorification of man, sanctity of family, parents and children, peaceful and peaceful life, appreciation of friendship and harmony, solving various problems together.

It has always been like this and will always be like this. That is why, not in the distant future, but today, large-scale reforms are being implemented to establish a pro-people system aimed at ensuring that our people live well, live a decent life and enjoy all opportunities. In the present conditions, when we are entering a new stage of development, it is repeatedly emphasized that "we need to organize our activities based on the motto that our great future begins today, and use all our strength and potential to ensure the prosperous life of our people."<sup>1</sup>.

Based on the instructions of the President of the Republic of Uzbekistan Sh.M. Mirziyoev to ensure the employment of the population and improve their lifestyle, today the "Iron Register", "Women's Register", and "Youth Register" are kept at the level of sectors to identify and eliminate the problems of families and citizens in need of social protection. A completely new system was introduced, which includes a wide range of measures. Based on this system, "Mahallabay", "Oilabay" and "Fuqarobay" have been established in our republic. These processes serve to improve the cooperation of internal affairs bodies in the place of law enforcement, prevention inspector directly with the neighborhood, and at the same time with citizens.

In fact, the main reason for committing crimes in society is the result of the lack of formation of spirituality in the individual or the failure to eliminate socio-economic problems in society. Today, the modern requirements of the formation of civil society in our country require the improvement

of the system to ensure the effective performance of the tasks performed by the neighborhoods. Citizens, who are considered an important part of any society, play the main role in the development and development of the state, maintaining its peace and tranquility. This has been proven since ancient times and has become a rule that should be followed today.

In addition, when the members of the society live in harmony in the state where the rule of law is ensured, at the same time, their trust in the state bodies increases, and in turn, the characteristics of patriotism and obedience to the laws are formed in them.

In this regard, the President of the Republic of Uzbekistan, Shavkat Mirzeyev, said: "Based on the principle of "Justice under the rule of law", we will continue our efforts aimed at strengthening the sense of respect for the law and intolerance of violations in our society. In this regard, special attention is paid to the prevention of violations in law enforcement agencies. For this, first of all, we need to take measures to widely use the opportunities of the neighborhood, increase the work efficiency and responsibility of preventive inspectors of the law-enforcement center, and create decent service and living conditions for them.<sup>2</sup>

At the current stage of the reforms, special rules are defined to ensure the cooperation of the preventive inspector of the law-enforcement center with the citizens. In particular, in accordance with the decree of the President of the Republic of Uzbekistan dated March 26, 2021 "On measures to raise the quality of the activities of internal affairs bodies to a new level in the field of ensuring public safety and combating crime" No. PF-6196 A clear example is the implementation of the "Smart Mahalla" information program, which allows monitoring the process, establishing quick communication with the population, evaluating the activities of prevention inspectors and sector leaders.

The creation of this program ensures the closeness of citizens with the prevention inspector of the law-enforcement center, as well as the establishment of public control over the work carried out in the field of crime prevention in the area.

The fact that the purpose of the Law of the Republic of Uzbekistan "On Public Control" dated April 12, 2018 is to organize public control over the activities of state bodies and institutions and to regulate relations in the field of implementation<sup>3</sup> also ensures the participation of citizens in the implementation of public control.

It should be noted that every citizen is responsible for ensuring peace and tranquility in the place where he lives, he should always be active and proactive in this regard, and should not be indifferent to any negative situation. In the formation of such characteristics, the role of the preventive inspector of the law-enforcement center occupies a special place. In particular, it is important for the prevention inspector of the law-enforcement center to organize targeted legal promotion work among the population, to call citizens to regular awareness.

It is known that turning every neighborhood into a crime-free area, ending the cases of indifference

and indifference in this regard is one of the main conditions for ensuring a peaceful and peaceful life in the society. In this regard, it is very important to create the feeling that "Crime should not happen in my neighborhood" in the mind of every citizen.<sup>4</sup>.

It should be noted that today there are a number of factors that hinder the effective organization of the cooperation of preventive inspectors of the law enforcement center with citizens. These include, firstly, the lack of confidence of citizens in internal affairs bodies; secondly, the lack of a clear mechanism for ensuring cooperation between the preventive inspector of the law-enforcement center and citizens; thirdly, ensuring peace and tranquility among citizens, lack of participation in crime prevention, etc.

Therefore, it is appropriate to create a mechanism for the prevention inspector of the law-enforcement center to cooperate with citizens, gain their trust, and implement the necessary measures to increase the activity of citizens in crime prevention.

It should be noted that the cooperation of the prevention inspector of the law-enforcement center with citizens has wide opportunities, therefore, it is important to use them effectively and to plan and implement targeted measures in the following directions:

- prevention of criminal and administrative offenses, exchange of information about them;
- to carry out large-scale control works in the administrative area, in turn, to organize and implement cooperation works with citizens and volunteers, following the saying "keep your own house";
- maintaining public order and ensuring the safety of citizens in the administrative area;
- organization and implementation of general, special, individual and victimological prevention of offenses in the administrative territory;
- ensuring compliance with passport-visa and control-licensing rules in the administrative territory;
- identification of banned organizations, religious-extremist groups and persons involved in similar activities;
- taking measures to identify and expose crimes committed in the administrative territory;
- to search for missing persons who have committed a crime and are hiding from the courts and investigative bodies, as well as convicts who are evading punishment as a form of correctional work, and to determine the identity of unidentified corpses;
- providing assistance to persons affected by crime;
- elimination of the consequences of emergency incidents.

In short, cooperation of the prevention inspector of the law enforcement center with citizens in the implementation of crime prevention should, firstly, be clearly planned, secondly, be organized on a voluntary basis, thirdly, measures should be taken to increase the activity of citizens, and fourthly, by increasing the social and political activity of society members. is provided.
